Ms.U.C.Nithiya, 1/66 A, Sundarrajan Patti, Alagarkovil Main Road, Aruumbanoor(po), Madurai – 625 104 working as Assistant Professor (SF), Yadava College, Govindarajan Campus, Madurai – 625 014 has been provisionally registered for the Ph.D. as a **Part Time** Scholar from **27.02.2020**. The Subject Title (@) and the School / Department / College / Institution he / she proposes for doing Ph.D. research work have been approved. He/ She should work in the School / Department / College/ Institution and under the following Supervisor (*) approved for the purpose as per the **Ph.D. Regulations of Madurai Kamaraj University framed according to UGC Regulations 2016**.

He/ She should complete the course work viz., **one course work paper on Research Methodology and one course work paper** (relevant to the subject paper of the research) **within one year from the date of registration** as mentioned under provision 6 of the Ph.D. regulations in force. The candidates with M. Phil., degree in the relevant fields of research shall be exempted from the course work on research Methodology. He/ She should submit his/her thesis **not earlier than 27.02.2023 and not later than 26.02.2026**.

A Research Advisory Committee should be formed for each candidate with an external subject expert nominated by the Vice-Chancellor to monitor the progress as stipulated in the Ph.D. regulations of Madurai Kamaraj University. The candidate should publish atleast 2 (two) research papers relevant to the area of research as first author in National/ International journals as listed by the UGC for submission of the Ph.D. thesis, following the amendments implemented from 24.05.2019.

After completion of the course work, the Ph. D registration shall be confirmed and he/she will be permitted to undertake the research work leading to the submission of Ph. D thesis as mentioned under provision 6 of the Ph. D regulations in force. The other terms and conditions regarding change of subject/ guide/ title, submission of thesis, synopsis, duration of the research, payment of fees, Cancellation etc., are available in the University website 'www.mkuresearch.org'.

He / She should pay **Rs.7,000/- as Research Fee to the College** and **Rs. 8,000/- as Administration Fee to the University** (for Science Candidate) on the given registration date of every year till submission of thesis. Fee for every year may be remitted within 30 days of the registration day of every year. One month grace period may be availed by the candidate by paying the penal fee of Rs.500/-. Even after this period if the fee is not paid the Registration shall stand automatically cancelled.
