After completion of the course work, the Ph. D registration shall be confirmed and he/she will be permitted to undertake the research work leading to the submission of Ph. D thesis as mentioned under provision 6 of the Ph.D. regulations in force.

The other terms and conditions regarding change of subject/ guide/ title, submission of thesis, synopsis, duration of the research, payment of fees, Cancellation etc., are available in the University website '[www.mkuresearch.org](http://www.mkuresearch.org)'.

He/She should pay the **Rs. 10,000/- as Research fee and Administration fee** (for Arts / Humanities Candidate) on the given registration date of every year till submission of thesis. Fee for every year may be remitted within 30 days of the registration day of every year. One month grace period may be availed by the candidate by paying the penal fee of Rs.500/-. *Even after this period if the fee is not paid the Registration shall stand automatically cancelled.*
