


This Memorandum of Understanding [MoU] is entered into on the 15th day of April, 2021 between the Department of Biotechnology, The Madura College (Autonomous), Madurai 625 011, represented by its Principal & Secretary herein after called FIRST PARTY and Office of the Assistant Director, Department of Sericulture, Namakkal 637 003 herein after called SECOND PARTY.

The Department of Biotechnology, The Madura College (FIRST PARTY) and Office of the Assistant Director, Department of Sericulture, Namakkal 637 003 recognize the strength in education, practical training and research in accordance with their individual mission and objective to foster and identify their areas of mutual interest for college and the sericulture industry.

Now therefore Memorandum of Understanding by FIRST PARTY and SECOND PARTY witnessed as under:

- 1. To exchange information on teaching and learning materials relevant to their education and research programmes.
- 2. To invite the experts from the Office of the Assistant Director, Department of Sericulture, Namakkal 637 003 for delivering guest lectures and act as members of Board of Studies in Sericulture Technology.
- 3. To jointly organize short-term training programmes on topics of mutual interest and to invite each other's faculty/staff to participate therein.
- 4. To provide hands-on training and internship training insericulture technology for the students of The Madura College.
- 5. To provide employment opportunity for the students of The Madura College
- 6. To establish Sericulture technology unit in the College
- 7. To conduct the extension programme in the form of exhibition and awareness program in order to popularize and develop their interest in Sericulture industry.

Every year the partners will evaluate the number and extent of activities and, where it is considered necessary, agree on any adjustment that should be made in the subsequent year to redress any imbalance.

Student exchanges:

The Department of Biotechnology, The Madura College and Department of Sericulture, Namakkal agree that student's exchanges shall be confined to Certificate, Diploma, and Undergraduate, Post graduates and researchstudent exchanges between both the institutions for doing their internship, course work, projects and other research work as well as training.

Joint Conferences, Workshops and Short-term Courses:

The Department of Biotechnology, The Madura College and Department of Sericulture, Namakkalagree to help identify and invite faculty members from other institutions to participate in conferences, workshops and short-term courses. The terms and conditions for such participation will be worked out by mutual agreement between the invited faculty member(s) and the institutions extending such an invitation. When a faculty member visits the other institution on invitation or as part of such joint activity, then such a visit will be classified as such, and handles as per the rules of the respective institution.

Duration of the Agreement

This agreement will take effect from the date it is signed by representatives of the two institutions. It will remain valid for five years, and may be continued thereafter after suitable review and agreement.

Arbitration and Termination

In the event of any dispute, difference or disagreement arising out of or in connection with this agreement, the matter will be referred in the first instance to Department of Sericulture, Namakkaland Principal & Secretary of The Madura College. They will endeavour to resolve the matter in a spirit of interdependence, mutual respect, and shared responsibility.

Either party may terminate the agreement by giving written notice of not less than 180 days to expire on the proposed termination date. Agreements for termination must include provision by Office of the Assistant Director, Department of Sericulture, Namakkaland The Department of Biotechnology, The Madura College for continuing students to complete their studies and the period of notice should take account of any re-assessment requirements that may be outstanding.

Intellectual Property

The Department of Biotechnology, The Madura College and Office of the Assistant Director, Department of Sericulture, Namakkalagree to respect each other's rights to Intellectual property. Further, the intellectual property rights that arise as a result of young collaborative research or activity under this agreement will be worked out on a case-by-case basis, and will be consistent with officially laid down IPR policies of the two institutions.

Publicity materials:

Office of the Assistant Director, Department of Sericulture, Namakkaland The Department of Biotechnology, The Madura College will not include the name, visual identity, crest or logo of the other institution in any advertising or publicity materials without that institution's prior approval on a case-by-case basis. The format and style of any visual identity and logo, and advertising and publicity material relating to the agreement and any guidelines for their use, and responsibility for funding such materials must be agreed to jointly by Office of the Assistant Director, Department of Sericulture, Namakkal and Principal & Secretary, The Madura College prior to the appearance in the media.

The legal dispute of this Memorandum of Understanding will be at the jurisdiction of Tamil Nadu.
